DPH Nightingale Award for Excellence in Nursing:**



The Nightingale award is a program developed by the Visiting Nurse Association of South Central Connecticut to be a collaborative effort to acknowledge outstanding nurses and elevate the nursing profession. The goals of the program are to encourage retention, inspire future nurses, focus public attention, and recognize the breadth and scope of nursing practice. Since inception, the program has grown to include Eastern Connecticut, Fairfield County, Hartford, along with the original program in New Haven.

In honor of National Nurses Week, the DPH sponsored its first annual DPH *Nightingale Awards for Excellence in Nursing*. The nominee was eligible for the 8th annual Hartford regional award. And the winner was

A Profile of Nurses Working in Connecticut's Health Departments-- State Health

Published in 2006, the report is an assessment to provide context for strategic planning to enhance a statewide public health nursing network

The Connecticut public health system was established in 1878. There are two tiers, the state health department and local health . Local health agencies vary in size, composition and provision of service.

The state Department of Public Health (DPH) utilizes general classifications for nurses and two functional levels:

STAFF

- ◇ Clinical Nurse 1
- ◇ Nurse Consultant
- ◇ Utilization Review Nurse Coordinator


SUPERVISOR

- ◇ Supervising Nurse Consultant

In addition, nurses work in non nursing titles throughout the agency as staff and managers. 75% of the nursing positions at DPH are within regulatory services

Scope and Standards of Public Health Nursing Practice

Above is the VOPHN logo, symbolizing the bridges we are building to foster public health nursing in Connecticut.

The scope and standards were updated by a working group convened by the American Nurses Association. Published in 2007, the scope and standards

- ◇ Articulates the essentials of public health nursing
- ◇ Is the core resource for nurses who focus their professional life in public health nursing
- ◇ Articulates six standards of nursing practice and ten standards for nursing professional performance
- ◇ Each standard sets a measurement criteria that reflect the values and priorities of the public health nursing specialty

Public health practice embraces all those actions that are directed to the assessment of health and disease problems in the population; the formulation of policies dealing with such problems; and the assurance of environmental, behavioral, and medical services designed to accelerate favorable *health trends and reduce the unfavorable*

PAT GANNON 1ST Annual DPH Nightingale Award winner



Pat Gannon has been employed since August 2000, as a Nurse Consultant at the DPH, FLIS. Pat is assigned to the complaint unit and is responsible for investigating complaints and conducting licensure and certification surveys in a variety of health care settings including general hospitals, ambulatory surgical centers and long term care facilities. Pat continually exceeds expectations with regards to the quality of her investigations and survey competence and knowledge. Pat has proven to be a vital asset in the Department's ability to respond to customer needs.
